Year End Trophy Qualifications

Tim Steck stated this has been an unusual year and we have 4 drivers that have qualified for year-end trophies, but not for class trophies. After much discussion, it was decided they would receive the same trophy as all participants, but no class designation on the trophy.

Catch All Class

Ryan Rink presented the new class and qualifications.

- Class designation – “DDO” Daily Driven Open
- Rules:
 - Must pass tech and sound regulations
 - Must be driven to the event (no trailered cars) and currently registered for street use
 - Must compete as driven to event – No Tire Changes (unsecured/easily removed item may be removed, i.e. removable tops, unsecured sub-woofers etc)
 - Tires must be deemed street able by manufacture, i.e. DOT Hoosiers say not intended for highway use so would not be a “Street-able” tire, but various 60TW and higher tires are sold as street-able track and competition.
- No actual PAX will be assigned.
- This class will most likely attract more participants.
- A motion was made to add the “Catch All” class DDO for 2019. It was seconded and passed.

Blower Replacement

Jerry Braunberger provided a blower update. The Options he presented are:

- Repair the existing blower
- Purchase a new engine for the existing blower
- Purchase a new blower for around \$1500.00. Any new blower must be able to mount like the old one.
