



Meeting Notes  
December 4, 2002

Vice President Lorin Wamsley called the meeting to order at 7:05 p.m. President Cheryl Baugh was unable to attend. Secretary Cheri Wilson read the November minutes. Treasurer Jim Mueller was absent. No treasurer's report was given.

**Old Business**

Bren Wamsley, banquet chairman, presented the 2002 banquet survey results. We had a total of 106 attendees and approximately 34% responded to the survey. The general consensus was very favorable and all had a good time.

Bonnie Mueller stated we're waiting for the K&K insurance 2003 quote.

Bill Baugh and Bonnie Mueller will be meeting to rewrite the EESCC Bylaws.

Cheri Wilson will contact Ann Wilkinson at Late Community College in regards to LCC as a site for a capped EESCC member only test and tune day. Suggested date may be after "IceBreaker" and before Event 1 and 2. It was suggested that a portion of the proceeds be donated to a helper group as a fund raiser (i.e. high school student club or other)
