The insurance would provide liability coverage should an action be brought against the club. Currently officers could be held personally responsible. The board directed Jerry to complete the application and submit it for a final quote. Bonnie Mueller will check with our current event insurance company and will also verify whether a rider policy could be attached to cover our equipment at least during event weekends and present at the April meeting.
