New Business

Worker Incentive Proposal

A worker incentive proposal developed by Bonnie Mueller and Tim Steck was presented and discussed. The proposal was a reward program for workers who assisted with pre-event set up and after event tear down activities. Rewards of free entry to a club event would be provided to drawing winners. A motion to accept the proposal was passed. The Icebreaker event would be used as a trial run for the 2007 Worker Reward Program. Change of Annual Tech Rule

A proposal for a change in the annual tech rule was presented by Bill Baugh.

The proposed revision would places the emphasis on the vehicle for which a least one driver was a season trophy winner from the previous year AutoX series qualifies for the annual inspection exception rather than the individual driver as is presently stated in the rule. As a result of this change in wording; a second driver who was driving a vehicle that qualified for the annual inspection under this rule; would not have to have this vehicle pass a tech inspection. Attachment #1 – Annual Tech Rule Change

7 February 2007

Proposed change in annual tech rule:

The EESCC 2006 Autocross Rulebook reads, at page 6, in part as follows:

4. VEHICLE PREPARATION FOR COMPETITION (SELF TECHING IS ALWAYS A GOOD IDEA.) **SAFETY** - Each vehicle will receive and must pass a technical safety inspection prior to competition.

2006 Annual tech Inspection. The only qualifying individuals for annual inspection are season trophy winners from our 2005 Auto-X Series. Those individuals will have a tech inspection at their first event. Throughout the year some of these individuals will be randomly re-teched. Any vehicle will be re-teched after an incident on or off the course, or at the discretion of EESCC officials. Each competing vehicle shall maintain a safe operating condition throughout the event or it will be excluded from competition until the condition has been rectified. The main purpose of technical inspection is to identify any safety deficiencies and not to determine vehicle conformance to class rules. Each vehicle must comply with the following points:

I propose the following revisions (indicated in red and *italics*):

2007 Annual tech Inspection. *Only vehicles for which at least one 2007 driver was a season trophy winner from our 2006 Auto-X Series qualify for annual inspection.* Those *vehicles* will have a tech inspection at their first event. Throughout the year some of these *vehicles* will be randomly re-teched. Any vehicle will be re-teched after an incident on or off the course, or at the discretion of EESCC officials. Each competing vehicle shall maintain a safe operating condition throughout the event or it will be excluded from competition until the condition has been rectified. The main purpose of technical inspection is to identify any safety deficiencies and not to determine vehicle conformance to class rules. Each vehicle must comply with the following points: ...

My logic in proposing these revisions is that we tech cars, not drivers, and our rules already state that "the main purpose of technical inspection is to identify any safety deficiencies..." This change would remove the requirement that, if two or more drivers share a car but only one of them trophied in the previous season, one driver would have to have the car teched at each event while the other would not. This would be a convenience not only to drivers, but to tech inspectors, whose workload would be reduced.
