Bonnie will be inviting a professional drone operator to test control frequencies and radio frequency during the blind autocross to determine whether there are any issues with our radios or timing equipment.

Service Contract Air Conditioner

Bonnie Mueller asked whether we should purchase a service contract on our newly purchased air conditioning unit. It's currently covered for 2 years. It won't run on one generator. We need to look at the amps the A/C pulls. Are the generators big enough? Jerry Braunberger will check it out.

Course Design – 5 Runs

Bonnie Mueller stated when we do course designs we need to be thinking about the overlap and the length of the runs to determine number of runs. We would like to have 5 runs at each event, but the overlap needs to support that. Lorin Wamsley said we need to look at our class splits to make sure morning and afternoon are as equal as possible with the number of drivers. We won't be changing splits until next year. Jim Mueller stated NFT's can influence the afternoon sessions.

Event 5 and 6 Planning

The following was discussed:
