Old Business

Additional Agenda Items:

Bonnie – she asked about having a trailer cleanup party. Bert responded he would wash the outsides, last year, the bearings were packed, so they are good. He will check tires, etc. Bonnie commented that the insides are dirty and messy. No cleaning party was scheduled.

We will give out a certificate for one set of NFT runs (Valid for events 1 through 7) to people who come and do both tech and check-in. The NFT certificate must be used in the afternoon AFTER a morning session has been paid for (either runs for trophy OR NFT runs). It will run 1-3pm. We will not do fun runs as we decided that is too much work. Peggy will send out an email and will post on Facebook if someone else does not. Tim or Peggy will create the certificate for NFT runs.

Peggy –went ahead and entered the club events in the NWCarEventsCalendar. I was not pleased with the form to enter events. It is completely geared for car shows, swap meets, etc. and did not have places for autocross information.
